

TERMS & CONDITION

A. Program Overview EncoreCM No Deposit Bonus Promotional Program allows all the new clients to get \$50 Free Money on their live trading account and start trading with free money. All New Clients of EncoreCM can sign up for Live account and get a No deposit bonus of \$50 Experience the power of trading and also enjoy the benefit of profit with EncoreCM Live Account without investing

B. Program Guidelines Terms of No deposit Bonus of \$50

1. General terms

- 1.1. The promotion is valid from once the client is registered with the promotion
- 1.2 The company-organizer is Encore Capital Markets
- 1.3 The Company reserves the right to change the promotional Trading Terms and conditions
- 1.4 The Company reserves the right to terminate the Program anytime

2. Participants

- 2.1 To claim your bonus you should register to Live Account of EncoreCM
- 2.2 Identification information is required while applying for the \$50 Bonus
- 2.3 Types of accounts involved in the promotion: No deposit bonus \$50 account with trading conditions similar to Rookie account.
- 2.4 Your account's leverage cannot exceed 1:400
- 2.5 The employees of the Company and their families cannot participate in the promotion.
- 2.6 Once the participant has been given a Live Account with \$50 Free Deposit, it shall be understood that he/she had read and agreed to the terms and conditions regarding the same.
- 2.7 Only a natural person can take part in promotion.
- 2.8 Deposits, Withdrawal and internal transfer on Bonus account are not available.

3. Withdrawal terms

3.1 The Bonus shall go automatically to the account in case of the compliance with all conditions.

3.2 Bonus is issued once. Reusing of bonus isn't possible.

3.3 Bonus funds are credited for 20 days on NDB account

3.4 After this period the bonus is deducted, open positions are closed.

3.5 The type of account also depends on the amount of profit made.

3.6 At the end of 20th day the Bonus \$50 will be taken back and the 50% of Profit i.e. between \$100-\$500 made on NDB account will be transfer to bonus trading account of the client as a tradable bonus.

3.7 Client needs to deposit on deposit bonus account same amount as bonus given to them for trading with EncoreCM.

3.8 Client needs to complete at least 20% of volume lot of bonus given to them in order to claim the bonus along with profit in their Bonus trading account.

3.9 Partial withdrawal of profit is not allowed.

3.9 Getting bonus and/or trading in bonus funds ON TWO OR MORE ACCOUNTS with same IP-address is prohibited.

3.10 Trading account with the bonus is prohibited to trade through anonymous proxy server. If the account with the bonus will connect with more than 5 different IP-addresses, the bonus will be canceled.

3.11 Multi Account hedging trade is prohibited in the bonus account. Any suspicious activity will result in immediate termination, In case of violation of this term the Company reserves the right to cancel the bonus and part of the profit earned as a result of the trade.

3.12 Bonus funds are the Company's property.

3.13 Failure of all mentioned terms of withdrawals can cancel the withdrawals of bonus & profit and treat client account as normal trading account of EncoreCM.

4. The claims

4.2 All claims should include the participant's name and address, account number and detailed description of the claim.

C. Trading Terms 20 days –No deposit Bonus Program Trading Terms;

I. The maximum profit/that can be made and claimed under No Deposit Program shall not exceed the \$500

II. All the profits made on the live deposit bonus Account can be claimed only after;

- The Client needs to deposits equivalent amount as the bonus given to them on their deposit bonus account

- The Client Trade and complete minimum 20% of volume on bonus given to them

- Client needs to use fair trade practice according to terms & condition of EncoreCM

D. Example of no deposit bonus Program

Mr. John signed up for the \$50 No deposit Bonus on our website and got a registered live account with \$50 free funding. Mr. John have started trading with this \$50 Free money for 20 days and made a profit of 500\$ (which is maximum he can claim) on the NDB account given within 20 days. Mr. John can claim the EncoreCM for bonus account @ support. EncoreCM will provide a deposit bonus account where Encore will give 50% of profit i.e. \$250 tradable bonus on client's new deposit bonus account where Mr. John will deposit \$250 equivalent to bonus given, now Mr. John have equity of \$500 and start trading and complete the volume i.e. 50 lots (20% of 250) to claim the profit & \$250 bonus of the account.
